March 6th, 2019 - Requirements for Receiving Spousal Support in Ohio There are no set guidelines for spousal support in Ohio The court determines the amount and duration of the support on a case by case basis Either spouse may seek spousal support whether husband or wife Who it will be awarded to is based solely on the income and resources of both spouses

## **Support and Alimony During and After an Ohio Divorce**

March 16th, 2019 - Many courts in Ohio in particular those in Summit County and the surrounding counties employ a "1/3 rule" which awards a spouse support for 1/3 of the length of the marriage i.e. if you were married for 15 years the court may award you spousal support for 5 years
